

## INFORMATION:

The current GM dealership, Gateway Motors, Inc., has been a dealership for in excess of 35 years, and its predecessor was active in the community for many years prior to the establishment of Gateway Motors, Inc.

The injuries to be suffered by the public as a result of the closure of the GM dealership would be numerous, including but not limited to:

- loss of significant sales tax revenues,
- loss of highly trained service personnel,
- loss of convenient warranty availability for GM vehicles,
- loss of direct employment of at least 14 employees,
- collateral losses in related businesses in both revenues, sales tax, and employment,
- extreme inconvenience to the population (especially the elderly) in that the closure of the local franchise would require a minimum roundtrip of approximately 100 miles for access to a GM dealership, warranty work, purchases of new and used vehicles, and normal service availability.

Broken Bow is located approximately 50 miles north of Lexington, Nebraska; 75 miles northwest of Kearney, Nebraska; 85 miles west-northwest of Grand Island, Nebraska; and 75 miles northeast of North Platte, Nebraska. The nearest significant urban populations to the north are over 100 miles away and to the west there are no significant urban populations for approximately 200 miles.
